1. Members of the Washington County Farm Bureau (for at least one year), their children, step-children, grandchildren or step-grandchildren, who are:
2. Current graduating high school seniors planning full-time enrollment at an accredited university, college, community college, junior college, or technical school; or
3. Currently enrolled full-time at an accredited university, college, community college, junior college, or technical school.
4. Completed applications are due by **Friday, March 15, 2019** in the Washington County Farm Bureau office, 1165 N. Meadowlands, Fayetteville, AR 72704. Applications available at same address or call 479-442-4266.

The intention of the Washington County Farm Bureau Scholarship is to encourage hard-working, determined students. Special consideration will be given to those studying in agriculture, family life sciences, or medical fields.

This one-time annual scholarship of \$1,000 is payable in increments of \$500 for two semesters, with the recipients to be recognized at the Washington County Farm Bureau annual meeting.
